ORDER U/S 12AA OF THE INCOME-TAX ACT

The Trust, herein known as **M/s. Bharatham Education and Social Trust, No.40, Tamil Nagar, IInd street, M.C.Road, Thanjavur-613 007** was created by a deed made on **20.07.2009** with the main objects of to help and give relief to the poor and illiterate by way of providing food, shelter, periodical distribution of clothes, medicines to the deserving poor and backward students: to provide medical help to the poor etc.

2. The Trust has furnished an application on 28.04.2011, in Form No.10A, under section 12A(a) of the Income-tax Act,1961, seeking registration u/s 12AA of the Act.

3. After due consideration of the objects of the Trust, the genuineness of the activities carried out by the Trust the registration is hereby granted u/s 12AA as **Public Charitable Trust with effect from 01.04.2011**. The Registration No. of the Trust is **8/2011-12**.

4. The applicant Trust shall abide by the provisions of Section 139(4A) of the Act and all other provisions of the Act, as may be applicable from time to time.

5. If at any stage it is found that the activities are either not genuine or are not being carried out in accordance with the objects, the registration granted may be cancelled, in terms of the provisions of Section 12AA(3) of the Act.

6. However mere registration u/s 12AA does not enable the applicant, the exemption under the provisions of section 11 to 13 or any provisions of the Income-tax Act, the Assessing Officer is free to make any intolities in this regard as deemed fit.
